Students learn the advanced theoretical knowledge, research and practice skills needed to function in increasingly complex care settings. ## accredited & achievable

- The master's degree in nursing program at King University is accredited by the Commission on Collegiate Nursing Education (http://www.ccneaccreditation.org).
- Member of the American Association of the Colleges of Nursing.
- Operates on an approval status with the Tennessee Board of Nursing
- The program is 20 months in duration.
- Areas of concentration to choose from:
  - Nurse Educator (NE)
  - o Nursing Administration (NA)
  - Family Nurse Practitioner (FNP)
  - Pediatric Nurse Practitioner (PNP)
- FNP and PNP are full-time options, with FNP meeting one day a
  week and PNP meeting in a blended format The other options
  meet in a hybrid, part-time format
- 35-45 semester hours are required, depending upon the concentration.
- The program is a cohort-based learning model.
- Smart phone or tablet and personal stethoscope is required for FNP/PNP.
- 395-600 clinical hours required
- Concentration specific plan of study sheets are available for review upon request.
- Admissions Deadline for Fall is March 1 and for Spring is October 1
- King University is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC)

## requirements

- Bachelor of Science in Nursing degree with transferrable course work in Health Assessment, Nursing Research/Evidence-based Practice and Statistics. (Pathophysiology is recommended for FNP, PNP and Nurse Educator). GRE exam is not required.
- Complete application online at apply.king.edu
- 2 recommendations one from a professional source and one from a former nursing instructor.
- 2-3 page researched-based writing sample prompt provided.
- Official transcripts from all colleges and universities you attended.
- A current, active, unencumbered license to practice as a registered nurse in Tennessee or another state that participates in the Nurse Licensure Compact agreement and any noncompact state in which the student is performing clinical requirements.
- Curriculum Vitae (one year as a practicing RN required for FNP & PNP).
- American Heart Association CPR card, and specialty certifications
- Laptop computer, with minimum of Office 2010 or later with wireless and webcam capability.
- Applicants for Nurse Educator, FNP and PNP may be invited for an interview.
